Legislative Updates

Channa reviewed the over view she provided the group via email prior to the meeting. Main helpful tool: sign up for notifications on your particular bills. Very difficult to follow a committee and it’s work.

OLIS.oregonlegislature.gov The systems to give testimony remotely are being developed, it seems to be difficult to access the system to sign up to provide testimony. Staff are prohibited from helping people sign up individually. You can email the committee to verify if someone has signed up successfully. If you are typing testimony in the chat box it will appear automatically, if you submit a pdf it takes more time for screening, size of documents are limited, they may have to be broken up in multiple submissions. House Civil Subcommittee is interested in guardianship bills- Chair Power has an interest in guardianship. How to best serve people in the hospital facing civil commitment.

579 Hearing set for March 23rd Chris notes it is not actually a community restoration program.

Channa notes there is some tension between political parties due to the building being closed and not open to the public and having the work of the legislature being conducted remotely.

Judge Holland noted that having remote court proceedings has in fact made proceedings more accessible in many cases.

Stakeholder Project Updates

- Allison with ODDS, working on pilot training related to supported decision making. Hopeful to partner with WINGS group members and other groups to get some pilot groups together. The goal is to use life corps stop light tool to identify types of decisions that need support, memorialize supported decision making
